

Hightower Emerging Leaders Fellowship

Introduction

The Hightower Emerging Leaders Fellowship connects a class of talented young professionals ("Fellows") with prominent and influential Jacksonville leaders. The Fellowship will foster meaningful relationships between our current and next generation of community leaders. The Fellowship program lasts from February through November, with Fellows meeting at least once each month.

Fellowship Benefits

Fellows will have the opportunity to network and learn from titans of Jacksonville who want to invest in the next generation. These sessions will take place in a setting that allows for candid discussion about how these leaders achieved their career success. 2018 speakers included Ed Burr, Tim Cost, Audrey Moran, John Peyton, Ambassador John Rood, Darnell Smith, Suzie Wiles, and others.

The caliber of participants selected for this program is unlike any other young professional group in Jacksonville, and will allow each Fellow to develop lifelong relationships with classmates and speakers.

Monthly Meetings

The monthly meetings will be an opportunity for Fellows to hear from a speaker about their professional background, experience, and gain insight on how they believe we can help make Jacksonville the best place to live, work and play. The meetings will be in a roundtable format and foster meaningful discussions between the speakers and Fellows.

All Fellows are required to attend the Hightower Fellowship meetings below with limited exceptions:

Program Kickoff (February)

Monthly Meetings (March - November)

Closing Reception (December)

Application Requirements and Process

All applicants must be members of ImpactJAX and the JAX Chamber and have no more than 15 years of professional work experience.

A selection committee will review all applications and will invite selected candidates to an inperson interview. From that group, Fellowship participants will be chosen.

Once selected as a Fellow, the participant fee of \$350 will be due before the program kickoff in February. Nonprofits will receive a \$100 discount.

How to Apply

All applicants are required to fill out the attached application and submit it for review, along with a resume and personal statement that answers the following question in 300 words or less:

"What changes would you like to see in our community and why?"
